In Accordance with sections 84, 85 & 89 of the Electricity Act, 2003, Government of Assam invites applications for 2 (two) post of Members, Assam Electricity Regulatory Commission (AERC) from persons who meet the following criteria :-

1. The person shall be of ability, integrity and standing who has adequate discerning knowledge of and has shown capacity in dealing with problems relating to engineering, finance, commerce, economics, law or management.
2. The person should not have any financial or other interest with any corporate entity dealing with Generation, Transmission, Trading and Distribution of electricity in Assam, which is likely to affect prejudicially his or her function as Member of the Commission. The person must give a certificate to this effect while applying for this post.
3. The Member shall hold Office for a term of 5 (five) years from the date he enters upon his Office or till he attains the age of 65 (sixty five) years, whichever is earlier.
4. The terms and conditions of Service of the members will be governed by the Notification as notified by the Government of Assam, Vide No. PEL.261/2016/67, dated 11.01.2018.
5. The Selection Committee constituted as per the provision of the Electricity Act, 2003 for the purpose of making the selection to the post of Member, reserves the right to consider and recommend any other person fulfilling the criteria laid down in the Act for the post of the Member apart from those who have applied against this advertisement. The Head Quarter of Assam Electricity Regulatory Commission is in Guwahati.
6. While filling up the post of Members in the Assam Electricity Regulatory Commission, the State Government will take into account the judgment of the Hon'ble Supreme Court of India dated April 12, 2018 in Civil Appeal No.14697 of 2015. As per the judgment one post is to be reserved for person of law background. Accordingly, on this post, person who is or has been holding a judicial office or is a person possessing professional qualifications with substantial experience in the practice of law, who has the requisite qualifications to have been appointed as a judge of the High Court or a District Judge is eligible to apply.

Suitable candidates with adequate qualification and requisite age as prescribed above may apply with their Bio-data mentioning their age, qualifications, experience, present status etc. within 1700 hours of 20th March, 2019 to Shri Niraj Verma, IAS, Principal Secretary, Power (Elect.)
